The MSBA is pleased to host the fourth annual Purebred Sheep and Club Lamb Sale in conjunction with the Northeast Livestock Expo. The sales Committee extends an invitation to sheep producers to enter consignments in both the pure bred and Club Lamb sale. We will be promoting the sale locally, regional and nationally as well as broadcasting real time Internet bidding by DV Auction. Information and instructions for PRE-registering is available at [www.dvauction.com](http://www.dvauction.com) Transportation of purchased animals can be arranged west to CA, north to Canada, south to TX and all points in between.

**Place:** The sale will take place at the Windsor Fair Grounds in Windsor Maine. Schedule changes will be posted at [www.northeastlivestockexpo.org](http://www.northeastlivestockexpo.org).

**Breeds:** The 2010 sale is open to all sheep breeds and club lambs. Breeding sheep require proper registration paper work to be eligible. Club lambs must be castrated prior to arriving at the sale. The sales committee and the event veterinarian will inspect all sheep prior to the sale for quality and soundness. Sheep that do not meet this standard will be removed from the grounds prior to the event.

**Identification:** All sheep consigned to the Purebred Sheep and Club Lamb Sale must be properly identified with an approved ear tag and accompanied by approved interstate health certificate. This is the responsibility of the consignor. For further information please see your state's USDA APIS Office or [www.aphis.usda.gov/vs/nahps/scrapie](http://www.aphis.usda.gov/vs/nahps/scrapie).

**Entry fees:** **\$10 per ewe or club lamb and \$15 per ram must accompany the entry form. Entry fees are non-refundable, but substitutions will be allowed. A commission of 10% will be charged on the amount over \$100 per head. All applicable commission is charged on any "No Sales." Entries should be mailed to: Lisa Webster, PO Box 1867, Windham, ME 04062.**

**Entries will not be considered without payment.**

**Deadlines:** The deadline for entries is April 1, 2010 for inclusion in the Sale Catalog.

**Campers:** Camper space will be available on site and hotel accommodations are available nearby, see [www.northeastlivestockexpo.org](http://www.northeastlivestockexpo.org) for more details.
