## WOOL POOL Moves to NELE for 2010!

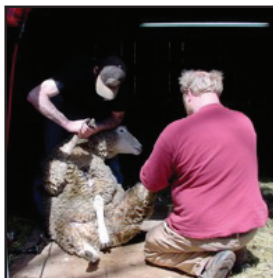
