Participants will indemnify and hold harmless the Expo for all damage, expenses or liabilities incurred as a result of any expense, loss, claims, cost or any liability, including, but not limited to, consultant fees, legal or court cost. A signed entry serves as an agreement to comply with all rules and regulations contained within this mailing and all other official Expo mailings.

An unsigned entry will be returned with any accompanying payment.
